Distribution or manufacturing of any drug including marijuana  
Breaking & Entering unless agree upon on case by case basis  
Felony act of violence (1<sup>st</sup> & 2<sup>nd</sup> degree murder or voluntary manslaughter or mob related felonies, kidnapping or abduction, any malicious felonious assault or malicious wounding, robbery, carjacking, criminal sexual assault, arson or structure burned was occupied)  
Use of a weapon during the commission of the offense or at time of arrest. (other standards outlined in eligibility criteria)

##### The defendant must not have prior convictions for:

Felony act of Violence within 10 years  
Possession with intent to distribute or distribution/ manufacturing or a Schedule I or drug within 10 years upon release from incarceration  
Any offense involving a firearm within 10 years  
Felony DUI within 5 years period following release from incarceration.  
More than two conviction for misdemeanor assault /battery or domestic assault within the 5 year period preceding the instant offense.
